(1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: This mini-review is focused on the mechanisms underlying therapeutic effects of yoga and its potential clinical applications in neurological and mental disorders. study is well written throughout. In the introduction section, if the authors describe more specifically the trends in yoga research (especially the mechanisms affecting brain health), it can help readers understand. The paper will benefit from extended discussion to address also some other fields of application like professional burn out; OCD and somatoform disorders, hypochondria; (3) Format: There is 1 table and 2 figures; (4) References: A total of 208 references are cited, including 61 references published in the last 3 years; (5) Self-cited references: There are 1 self-cited reference. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e. those that are most closely related to the topic of the manuscript) and remove all other improper self-citations.
