The topic is within the scope of the WJC. (1) Classification: Grade B and Grade B; (2) Summary of the Peer-Review Report: This review article describes a pre-participation</p>	[Y]

screening strategy with echocardiogram to prevent sudden cardiac death of an athlete. This is a well written and interesting review. However, the questions raised by the reviewers should be answered; and (3) Format: There are 11 tables and 2 figures. (4) References: A total of 165 references are cited, including 23 references published in the last 3 years; (5) Self-cited references: There are 19 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves. If the authors found the peer reviewer(s) request the authors to cite improper references published by themselves, please send the peer reviewer's ID number to the editorialoffice@wjgnet.com.
