The topic is within the scope of the WJSC. (1) Classification: Grade C, Grade D and Grade C; (2) Summary of the Peer-Review Report: This review discusses Neural stem cell therapy for various brain diseases, which is interesting. However, the weight is not distributed very evenly. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table. (4) References:</p>	[Y]

A total of 60 references are cited, including 17 references published in the last 3 years; (5) Self-cited references: There are 2 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations.
