The topic is within the scope of the WJCC. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: In this study, the authors explored the</p>	[Y]

expression characteristics of the Caspase-3 and the HIF-1 α in tissues, and their relationship with the biological behavior with hepatocellular carcinoma complicated by the hemorrhage and necrosis. The study design is good, and the methods are described in detail. The results are interesting and well discussed. The questions raised by the reviewers should be answered; (3) Format: There are 5 tables; (4) References: A total of 20 references are cited, including 10 references published in the last 3 years; (5) Self-cited references: There is no self-cited references; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
