The topic is within the scope of the WJSC. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The authors found a review article examining the therapeutic effect of MSCs on meniscus injury, which is of high</p>	[Y]

importance in musculoskeletal disorders. Essential clinical, morphological, and immunohistochemical data were given. However, the manuscript lacks several themes to be discussed for the readers. The questions raised by the reviewer should be answered; and (3) Format: There are 2 tables and 3 figures. (4) References: A total of 143 references are cited, including 8 references published in the last 3 years; (5) Self-cited references: There is 1 self-cited reference. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves.
