The topic is within the scope of the WJP. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The authors discussed about the early intervention in OCD, before the conclusion. But, it is not clear, whether they want to</p>	[Y]

discuss about the initiation of treatment in OCD early in order to reduce the duration of untreated illness or they want to discuss about early initiation of anti-glutamatergic agents in the management of OCD. The authors may also discuss the role of neuromodulation techniques, that also modulate the glutamatergic system; (3) Format: There are no tables and no figures; (4) References: A total of 96 references are cited, including 12 references published in the last 3 years; (5) Self-cited references: There is 1 self-cited reference. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e. those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). Please provide the author contributions; and (2) Please add table/figure to this review. 6 Re-Review: Not required. 7 Recommendation: Conditional acceptance.</p> <p>Company Editor-in-Chief: I have reviewed the Peer-Review Report, the full text of the manuscript, and the relevant ethics documents, all of which have met the basic publishing requirements of the World Journal of Psychiatry, and the manuscript is conditionally accepted.
