the treatment of diabetic ED, including the pathogenesis of diabetic ED, the diagnostic criteria of ED, and the treatment of diabetic ED. It focuses on the progress of stem cell therapy for the treatment of ED in diabetes. The advantage over other therapies is to treat ED from the root of tissue damage. The questions raised by the reviewers should be answered; (3) Format: There are 2 tables and 1 figure; (4) References: A total of 68 references are cited, including 20 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
