evidence supporting the SPM, and the implications of the SPM in translational oncology and, discussed potential strategies for cancer treatment. It is very interesting; (3) Format: There are 2 figures; (4) References: A total of 78 references are cited, including 37 references published in the last 3 years; (5) Self-cited references: There are 5 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e. those that are most closely related to the topic of the manuscript) and remove all other improper self-citations.
