2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a retrospective study of the CA19-9 level to Serum γ-glutamyltransferase as a novel prognostic indicator in patients with distal cholangiocarcinoma. The topic is within the scope of the WJG. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: This study is interesting in that it is difficult to assess the precise</p>	[Y]

prognostic value of CA 19-9 in biliary tract cancer with jaundice. In terms of offsetting the interaction between CA 19-9 and jaundice, this study contains new content. However, the manuscript has some limitations; and (3) Format: There are 6 tables and 4 figures. (4) References: A total of 31 references are cited, including 8 references published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves. If the authors found the peer reviewer(s) request the authors to cite improper references published by themselves, please send the peer reviewer's ID number to the editorialoffice@wjgnet.com. The Editorial Office will close and remove the peer reviewer from the F6Publishing system immediately. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by Editage was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form, and Written informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by 2 grants. The topic has not previously been published in the WJG. 5 Issues raised: (1) The title is too long, and it should be no more than 18 words; (2) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or
