In addition, the authors specified the latest part of the manuscript for the ethical concerns regarding the safety and efficacy of these by-products and they concluded that unraveling the utility of various adipose derivatives</p>	[Y]

helps in the improvisation of the existing regenerative therapies and their associated biomedical applications. The topic is not within the scope of the World Journal of Stem Cells. 1. Scientific quality: 1) Classification Grades B, C; 2) Summary of the Peer-Review Report: Overall, the authors drafted a well-written manuscript with an interesting topic. The questions raised by the reviewer should be answered; 3) Format: 4 figures are found and there are no tables; 4) References: A total of 165 references are cited, including about 50 references published in the last 3 years, the authors should follow the standard reference style of the journal; 5) Self-Cited references: Self-cited references not found. 2. Language evaluation: Classification: Grades B, B. A language editing certificate is not provided. 3. Academic norms and rules: The authors didn't provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found by the Bing search. 4. Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published. 5. Issues raised: 1) Overall, the manuscript should be reformatted to follow the journal style. 2) Core tip should be added 3) the authors should avoid the repetition of paragraphs in the abstract and main text. 6. Re-Review: Not required; 7. Recommendation: Transfer to another journal likely as World Journal of Meta-analysis.
