The topic is within the scope of the WJGO. (1) Classification: Grade A and Grade B; (2) Summary of the Peer-Review Report: In this study, the authors analyzed the effect of robotic resection and open surgery in the treatment of duodenal</p>	[Y]

gastrointestinal stromal tumors. This study is designed well, and it can provide a reference for scientific and reasonable selection of surgical treatment for duodenal gastrointestinal stromal tumors. The questions raised by the reviewers should be answered; (3) Format: There are 3 tables and 2 figures; (4) References: A total of 24 references are cited, including 9 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). If the authors find the peer reviewer(s) request for the authors to cite improper references published by him/herself (themselves), please send the peer reviewer's ID number to editorialoffice@wjgnet.com. The Editorial Office will close and remove the peer reviewer from the F6Publishing system immediately. 2 Language evaluation: Classification: Two Grades B. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study.
