Summary of the Peer-Review Report: The manuscript proposes the CEUS model enables the well-calibrated individualized prediction of ER before surgery and may represent a novel tool for biomarker research and individual counseling. The quality and importance of this manuscript is statistical analysis. However, the questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 6 figures. (4) References: A total of 30 references are cited, including 16 references published in the last 3 years; (5) Self-cited references: There is 1 self-cited reference. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves.
