The topic is within the scope of the WJGE. (1) Classification: Grade A and two Grades B; (2) Summary of the Peer-Review Report: This is a review article that described a broad overview and decision algorithm on the endoscopic evaluation and management of colorectal polyps. This review article is well written and</p>	[Y]

comprehensive about this topic. The questions raised by the reviewers should be answered; (3) Format: There is 1 table and 6 figures; (4) References: A total of 78 references are cited, including 42 references published in the last 3 years; (5) Self-cited references: There are 8 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e. those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
