Peer-Review Report: The authors retrospectively compared the short- and long-term outcomes between laparoscopic and open ICR for the treatment of ileocolic CD, found that the laparoscopic procedure had better shor-term outcomes and comparable long-term outcomes compared to open group. It is very interesting and well written. However, the inclusion and exclusion criteria were not clearly stated. The questions raised by the reviewers should be answered; and (3) Format: There are 5 tables and 2 figures. (4) References: A total of 42 references are cited, including 6 references published in the last 3 years; (5) Self-cited references: There are 3 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves. I have sent the manuscript to the author(s) for its revision according to the Peer-Review Report, Editorial Office's comments and the Criteria for Manuscript Revision by Authors.
