2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor:</b> 1 Scientific quality: The manuscript describes a retrospective cohort study of the short-term and long-term outcomes of laparoscopic versus open ileocolic resection in patients with Crohn's disease. The topic is within the scope of the WJG. (1) Classification: Grade B and Grade B; (2) Summary of the</p>	[Y]

Peer-Review Report: The authors retrospectively compared the short- and long-term outcomes between laparoscopic and open ICR for the treatment of ileocolic CD, found that the laparoscopic procedure had better shor-term outcomes and comparable long-term outcomes compared to open group. It is very interesting and well written. However, the inclusion and exclusion criteria were not clearly stated. The questions raised by the reviewers should be answered; and (3) Format: There are 5 tables and 2 figures. (4) References: A total of 42 references are cited, including 6 references published in the last 3 years; (5) Self-cited references: There are 3 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves. If the authors found the peer reviewer(s) request the authors to cite improper references published by themselves, please send the peer reviewer's ID number to the editorialoffice@wjgnet.com. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text. 6 Recommendation: Conditional acceptance.</p> <p><b>Company Editor-in-Chief:</b> I have reviewed the Peer-Review Report, full text of the manuscript, and the relevant ethics documents, all of which have met the basic publishing requirements of the World Journal of Gastroenterology, and the manuscript is conditionally accepted.
