The topic is within the scope of the WJR. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: This is a well</p>	[Y]

written clinical paper with simple methodology and clear findings. The main finding is that SUVmax/mean is higher in symptomatic shoulders rather than asymptomatic shoulders for lung cancer patients. The questions raised by the reviewers should be answered; (3) Format: There are 3 tables and 2 figures; (4) References: A total of 17 references are cited, including 1 reference published in the last 3 years; (5) Self-cited references: There is no self-cited reference. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e. those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). If the authors find the peer reviewer(s) request for the authors to cite improper references published by him/herself (themselves), please send the peer reviewer's ID number to editorialoffice@wjgnet.com. The topic has not previously been published in the WJR. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (4) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text. 6 Re-Review: Not required. 7 Recommendation: Conditional acceptance.
