Science Editor: 1 Scientific quality: The manuscript describes a Review of the inflammatory bowel disease-related colorectal cancer. The topic is within the scope of the WJGO. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: Authors discussed introduction of novel endoscopic technologies, artificial intelligence and potential use of microbiota modulation. Overall, this is a well-written article. The questions raised by the reviewers should be answered; (3) Format: There are 3 tables and 4 figures; (4) References: A total of 162 references are cited, including 39 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference; and (6) References recommendations (kindly remind): The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
