The authors should discuss how they indicate hepatectomy. The authors describe disease free of the patients after hepatectomy. Imaging devices and timing that confirm disease free should be</p>	[Y]

described in the main text. In the abstract, the author didn't address de additions to the medical literature provided by this report. The inclusion of a timeline including the landmarks of this case and organizing the treatments (surgeries, chemotherapies, radiotherapy) would clarify the understanding. About the loss of follow-up, the authors should inform if the medical records or the civil registers in their country give any information about possible outcomes of the patient The questions raised by the reviewers should be answered;

(3) Format: There are 4 figures; (4) References: A total of 14 references are cited, no references published in the last 3 years; (5) Self-cited references: There are no self-citations; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
