of patients with RA in everyday activities. The sample size seems to be adequate and conveys good quality comparison. The questions raised by the reviewers should be answered; (3) Format: There are 4 tables and 1 figure; (4) References: A total of 41 references are cited, including 18 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
