of GIP determination compared to the available tools in use. It is well written. The reviewer suggests the authors to add a table summarizing the existing studies on GIP which could be very useful for the readers. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 1 figure. (4) References: A total of 67 references are cited, including 22 references published in the last 3 years; (5) Self-cited references: There are 17 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e., those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text; (4) There are 17 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e., those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; (5) I have changed the manuscript type “review” to “systematic review”. 6 Re-Review: Not required. 7 Recommendation: Conditionally accepted.
