	(4) References: A total of 47 references are cited, including 12	
	references published in the last 3 years; (5) Self-cited references:	
	There is 1 self-cited reference. The self-referencing rates should be	
2	less than 10%. Please keep the reasonable self-citations (i.e., those	[Y]
-	that are most closely related to the topic of the manuscript) and	[+]
	remove all other improper self-citations. If the authors fail to	
	address the critical issue of self-citation, the editing process of this

Statistical significance is expressed as aP < 0.05, bP < 0.01 (P > 0.05 usually does not need to be denoted). If there are other series of P values, cP < 0.05 and dP < 0.01 are used, and a third series of P values is expressed as eP < 0.05 and fP < 0.01. 6 Re-Review: Not required. 7 Recommendation: Conditionally accepted.
