2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a retrospective cohort study of the direct-acting antivirals for chronic hepatitis C treatment in Brazil. The topic is within the scope of the WJH. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: It is an interesting study. However, there are some issues need to be addressed. The questions raised by the reviewers should be answered; and (3) Format: There are 6 tables. (4) References: A total of 47 references are cited, including 12 references published in the last 3 years; (5) Self-cited references: There is 1 self-cited reference. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e., those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). If the authors find the peer reviewer(s) request for the authors to cite improper references published by him/herself (themselves), please send the peer reviewer's ID number to editorialoffice@wjgnet.com. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text; and (2) please don’t include any *, #, †, §, ‡, ¥, @....in your manuscript; Please use superscript numbers for illustration; and for statistical significance, please use superscript letters. Statistical significance is expressed as $aP < 0.05$, $bP < 0.01$ ($P > 0.05$ usually does not need to be denoted). If there are other series of P values, $cP < 0.05$ and $dP < 0.01$ are used, and a third series of P values is expressed as $eP < 0.05$ and $fP < 0.01$. 6 Re-Review: Not required. 7 Recommendation: Conditionally accepted.
