found a well-designed systematic meta-analysis to assess the non-invasive tests in determining prognosis of the chronic liver disease. The data is important to be added to the previous reports; and (3) Format: There are 5 tables and 6 figures. (4) References: A total of 52 references are cited, including 17 references published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves.
