2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor:</b> 1 Scientific quality: The manuscript describes a retrospective study of the minimal invasiveness of laparoscopic liver resection. The topic is within the scope of the WJH. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The authors have conducted an interesting study to compare the invasiveness of the open and laparoscopic liver resection. However, there are some issues need to be addressed. The sample size of the study is very small. Please check with the statistician whether it is meaningful to perform multivariate analysis for such small sample size. The incidence of complications in this study was high. Please provide the details about the major and minor complications in both the groups and compare them. The questions raised by the reviewers should be answered; and (3) Format: There are 6 tables. (4) References: A total of 29 references are cited, including 5 references published in the last 3 years; (5) Self-cited references: There are 3 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e., those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself</p>	[ Y ]

5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (3) I found the authors did not write the "article highlight" section. Please write the "article highlights" section at the end of the main text; And (4) the author should number the references in Arabic numerals according to the citation order in the text. The reference numbers will be superscripted in square brackets at the end of the
