These questions raised by the reviewers should be answered; (3) Format: There are 4 tables and 2 figures; (4) References: A total of 133 references are cited, including 56 references published in the last 3 years; (5) Self-cited references: There are 0 self-cited references. (6) References recommendations: There were no references recommendations by reviewers. 2 Language evaluation: Classification: Grade B and Grade A. No language editing certificate was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form.
