2	<i>Editorial Office's Comments</i> Science Editor: 1 Scientific quality: The manuscript describes an observational study of the COVID-19 experience among liver transplant centers. The topic is within the scope of the WJH. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: This is an original article regarding Liver Transplantation during the COVID-19 Pandemic. The topic is interesting. However, the manuscript has several limitations. The period of the study should be added in the abstract. The authors need to add the novelty of this study. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 4 figures. (4) References: A total of 16 references are cited, including 13 references published in the last 3 years; (5) Self-cited references: There is 1 self-cited reference. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e., those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; And (2) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text; 6 Re-Review: Not required. 7 Recommendation: Conditionally accepted.
