Science Editor: 1 Scientific quality: The manuscript describes a “Editorial” of the liquid biopsy in colorectal cancer. The topic is within the scope of the WJG. The corresponding author is the editorial board member of AIG. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: The authors provide a very interesting and clinically oriented overview on the subject of liquid biopsy concept in colorectal cancer. They nicely introduce the clinical need for better molecular assessment of solid tumors based on the emerging systemic therapies, which are highly dependent on the molecular characteristics of tumors. However, there are some issues need to be addressed. The questions raised by the reviewers should be answered; and (3) Format: There is 1 figure. (4) References: A total of 23 references are cited, including 17 references published in the last 3 years; (5) Self-cited references: There are 4 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e., those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). If the authors find the peer reviewer(s) request for the authors to cite improper references published by him/herself
