largest study in patients with hepatic PEComa who underwent liver resection. However, the questions raised by the reviewer should be answered; and (3) Format: There are 4 tables and 3 figures. (4) References: A total of 22 references are cited, including no references published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves.
