The topic is within the scope of the WJG. (1) Classification: Grade A and Grade C; (2) Summary of the Peer-Review Report: This manuscript reviews possible routes of the virus infection concerning the host-enzymatic systems responsible for the proteolytic priming of	[Y]

SARS-CoV-2. There is no review on the given topic, and thus the paper provides the reader with all the necessary information in one place. The manuscript is comprehensive and well-written; and (3) Format: There are no tables or figures. (4) References: A total of 43 references are cited, including 33 references published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). If the authors find the peer reviewer(s) request for the authors to cite improper references published by him/herself (themselves), please send the peer reviewer's ID number to editorialoffice@wjgnet.com.
