The topic is within the scope of the WJO. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The authors presented a case report of lumbar atypical osteochondroma in an 18 year old patient with previous</p>	[Y]

history of radiotherapy for suprasellar carcinoma and discussed the literature. It is concise and very well written. However, the questions raised by the reviewer should be answered; and (3) Format: There are 5 figures. (4) References: A total of 22 references are cited, including no references published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves. If the authors found the peer reviewer(s) request the authors to cite improper references published by themselves, please send the peer reviewer's ID number to the editorialoffice@wjgnet.com. The Editorial Office will close and remove the peer reviewer from the F6Publishing system immediately. 2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors provided the CARE Checklist-2016 and Written informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJO. 5 Issues raised: (1) The title is too long, and it should be no more than 18 words; (2) The "Author Contributions" section is missing. Please provide the author contributions; (3) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all

	<p>graphs or arrows or text portions can be reprocessed by the editor;</p> <p>(4) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (5) The “Case Presentation” section was not written according to the Guidelines for Manuscript Preparation.
