The topic is more suitable for World Journal of Clinical Cases. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: The authors described a history and clinical examination very clearly</p>	[Y]

and discussed well according to many reports on CDG patients with ATP6AP1 gene mutation. However, patients with ATP6AP1-CDG have been previously reported. The questions raised by the reviewers should be answered; (3) Format: There are 3 tables and 2 figures; (4) References: A total of 21 references are cited, including 9 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). If the authors find the peer reviewer(s) request for the authors to cite improper references published by him/herself (themselves), please send the peer reviewer's ID number to editorialoffice@wjgnet.com.
