Thank you for your pertinent suggestion. Yes, CAC is a subtype of CRC, but we chose to emphasize the role of innate immune cells also in colitis-associated cancer because their pathogenesis differs from classical CRC as explained in page 5.

-2. In page 14, the authors mention "Moreover, we hypothesize a direct role of HLA-G in influence the IS value considering its direct inhibitory properties over NK cells and CTLs ". Actually, there has been a lot of papers about the this aspect, like "Dan – Dan Dong, Shang – mian Yie, Ke Li, et al Importance of HLA – G expression and tumor infiltrating lymphocytes in molecular subtypes of breast cmcer Htunan Immunology 73 (2012): 998 – 1004. "

Yes, there are many papers about this topic but nobody until now mentioned a direct link between HLA-G and Immune Score. Therefore to strength our suggestion that reflects the enverse correlation among HLA-G expression and TILs, we decided to add this reference (Dong *et al*)<sup>[130]</sup> in the sentence you've cited in page 14.

-3. There are too many spelling and grammatical mistakes in this article, like ""highlithed and HLA G" in page 2 and "we hypothesize a direct role of HLA-G in influence the IS value ....."in page 14.


