1. Importantly, the authors need to significantly improve the writing.

Please note that four out of the five authors are native English speakers, and the authors feel that the current revised manuscript's flow of writing is up to the standards of this journal.

2. Keywords are not standard. Please match the keywords with the mesh.

The authors would like to thank the reviewer for the reviewer's time and recommendations. The authors revised the keywords utilizing the NCBI MeSH search tool to standardize said format as recommended.

3. The aim of the study should be referred in the introduction of the abstract.

The authors agree with this recommendation, and have added a sentence in the abstract to highlight the purpose of discussing the intersections of the clinical symptoms of TBI.

4. The addressed problem is not clear. Give more emphasis on the problems and the gap you intend to fill.

The authors agree with this statement, and have modified and extended on the sentence noted above in number 3.

5. Include criteria should be mentioned in the method section.

The authors agree with this statement. Upon further review, the authors realize that as this manuscript follows a focused narrative review format for this minireview, instead of a systematic review or a meta-analysis format, the authors restructured the title to clarify its format. With the focused narrative review format, it will not follow the systematic review format's identification of an inclusion criteria.

The authors appreciate this recommendation. As this manuscript has been further clarified as a focused narrative review, the authors have decided to abstain from using the systematic review format's PRISMA flow diagram.

(1) Classification: Grade C; (2) Summary of the Peer-Review Report: The work describes Mechanism of olfactory deficit in neurotrauma and its related affective distress. The manuscript is well organized and addresses the topic sufficiently. The questions raised by the reviewers should be answered; (3) Format: There is 1 figure; (4) References: A total of 44 references are cited, including 4 references published in the last 3 years; (5) Self-cited references: There is 1 self-cited reference. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e. those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). If the authors find the peer reviewer(s) request for the authors to cite improper references published by him/herself (themselves), please send the peer reviewer's ID number to editorialoffice@wjgnet.com.
