Report: The authors evaluated the relevant biomarkers for early prognosis and diagnosis of pancreatic cancer. It has significant findings for the service of public health; and (3) Format: There are 4 tables and 5 figures. (4) References: A total of 52 references are cited, including 9 references published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves.
