investigated the correlation between the genotype and clinical phenotype of Peutz-Jeghers syndrome. It is well written and highly interesting. The study is well designed and presented with optimal analysis, discussion, tabulation and graphic display of data. The questions raised by the reviewers should be answered; (3) Format: There are 5 tables; (4) References: A total of 29 references are cited, including 2 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
