2	<i>Editorial Office's Comments</i> Science Editor: 1 Scientific quality: The manuscript describes a prospective study which investigated how knowledge of CYP2D6 genotype impacted the decision for hormonal agent use and how CYP2D6 genotype and agent were associated with clinical outcomes for breast cancer. The topic is within the scope of the WJCO. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The authors conducted a useful prospective study. It provides some data on breast cancer. However, comments on format concerning abstract, keyword, and method raised by the reviewers should be addressed; (3) Format: There are 1 figures and 4 table in the manuscript. (4) References: A total of 26 references are cited, with no references published in the last 3 years; (5) Self-cited references: There are 0 self-cited references. (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves. If the authors found the peer reviewer(s) request the authors to cite improper references published by themselves, please send the peer reviewer's ID number to the editorialoffice@wjgnet.com.
