2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a case report of the successful treatment of patients with septic acute kidney injury induced by gastrointestinal infection with oXiris® hemofilter. The topic is within the scope of the WJCC. (1) Classification: Grade A and Grade C; (2) Summary of the Peer-Review Report: This is a good report. However, there are some</p>	[Y]

questions that need to be answered about the research of blood tests. The questions raised by the reviewers should be answered; (3) Format: There are 1 table and 2 figures; (4) References: A total of 12 references are cited, including 2 references published in the last 3 years; and (5) Self-cited references: There is no self-cited reference. 2 Language evaluation: Classification: Grade A and Grade B. A language editing certificate issued was provided. 3 Academic norms and rules: The authors provided the CARE Checklist (2016) and written informed consent. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCC. 5 Issues raised: (1) I found no "Core Tip", please add the "Core Tip", the content of Core Tip is controlled between 50-100 words; (2) I found the title was more than 18 words. The title should be no more than 18 words; (3) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (4) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout. 6 Recommendation: Conditionally accepted.
