The topic is within the scope of the WJEM. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: This manuscript reviewed the recent advance about using cfDNA as biomarkers for monitoring kidney transplant rejection. The value of the manuscript was apparent. The questions raised by the reviewers should be answered; (3) Format: There are 2 tables; (4) References:</p>	[Y]

A total of 69 references are cited, including 21 references published in the last 3 years; (5) Self-cited references: There are 2 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e. those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
