The topic is within the scope of the WJCC.</p> <p>(1) Classification: Grade C; (2) Summary of the Peer-Review Report:</p> <p>This manuscript assesses limited open reduction and screw fixation</p>	[Y]

among elder patients in a certain fracture pattern that is difficult to reduce in a closed manner. "Introduction" does enough briefing about the subject, the aim and the surgical technique presented in the paper. However, the manuscript lacks proper conclusions. In addition, English must be revised. The questions raised by the reviewers should be answered; (3) Format: There are 1 table and 2 figures; (4) References: A total of 18 references are cited, including 6 references published in the last 3 years; and (5) Self-cited references: There is no self-cited reference; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). If the authors find the peer reviewer(s) request for the authors to cite improper references published by him/herself (themselves), please send the peer reviewer's ID number to editorialoffice@wjgnet.com. The Editorial Office will close and remove the peer reviewer from the F6Publishing system immediately. 2 Language evaluation: Classification: Grade B. A language editing certificate issued was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form, and Written informed consent. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The

study was supported by National Natural Science Foundation of China. The topic has not previously been published in the WJCC. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (4) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text; and (5) Please write the “Conclusion” section at the end of the main text. 6 Recommendation: Conditionally accepted.
