Peer-Review Report: The authors proposed the hypothesis that glycyrrhizic acid and 18 β -glycyrrhetinic acid may have the ability to differentiate human umbilical cord derived mesenchymal stem cells into hepatocytes directly or aid in the process of differentiation. It is interesting, current and brings new perspective. However, the questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 7 figures. (4) References: A total of 37 references are cited, including 1 reference published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves.
