The topic is within the scope of the World Journal of Gastrointestinal Oncology. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: (05824555): The authors did a lot of work to gather, organize and discuss the state-of-the-art papers as well as recent works covering AI, ML and other trends in computer-generated image applications. Despite the good analyzes and review process, I believe that the Discussion section could be conducted under the analysis of some main/pivotal works, as mentioned in the previous sections. By doing this, readers could have an interesting comparison involving the pros and cons of the current works / methodologies / systems. However, given that the article does a good job of discussing the existing works, I would still recommend accepting this manuscript.
