The topic is within the scope of the WJCC. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The authors presented a case with laparoscopic treatment of a ruptured ovarian endometriotic cyst. Running title is not appropriate and does not indicate the main content of the case.</p>	[Y]

Details of how to calculate the preoperative and postoperative CA-125, Blood count and D-D et al, should be shown. Adding a table maybe a good choice. It is recommended to review the previous case reports and compare them with this case to show the uniqueness of this case; (3) Format: There is 1 figure; (4) References: A total of 20 references are cited, including 11 references published in the last 3 years; (5) Self-cited references: There are no self-citations; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
