(1) Classification: Grade B;</p> <p>(2) Summary of the Peer-Review Report: Reviewer 05351820 supposes that the authors have done an excellent and exhaustive review on the endoscopic antireflux therapy. The authors have well illustrated the special situations where such therapies can be tried. Reviewer suggested that the authors described the learning curve of the endoscopist for each of the procedures; financial implications, when compared to the surgical alternatives; and ask to provide authors' vision of the role of artificial intelligence in the future. Reviewer's recommendation: Accept (High priority). (3) The manuscript contains 2 tables of sufficient quality. (4) There are 97 literature references, 35 of them are published in last 3 years (which is >10%). (5) There is 1 self-citing (appropriate). (6) References recommendations The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially those published by the peer reviewer(s) him/herself (themselves). (F) No signs of Academic misconduct. Articles with similar titles found in PubMed are of older age and differ in content. Google search showed no similar titles published by the authors. 4 Supplementary comments: This is unsolicited manuscript, the authors reported no financial support. 5 Issues raised: The paper may be classified as a narrative review, with no need for change in the literature search methods description. I found no authors' contribution section in the manuscript. The manuscript would benefit if the authors provided schematic illustration of the described procedures. Key words require correction to enhance visualization of the paper in the search engines; "proton pump inhibitors" seems to be not applicable, as it does not fully reflect the content of the manuscript; I would suggest to add the names of the procedures; "treatment"; "gastroesophageal reflux disease". My recommendation is to polish the phrase on page 5 "Many other factors also favor GERD development, including tobacco and certain drugs, such as calcium blockers and tricyclic antidepressants" with the substitution of the "development" by "triggering" or "exacerbation". 6 Re-review: required 7 Recommendation: Conditional acceptance.</p> <p>Company Editor-in-Chief: I have reviewed the Peer-Review Report, full text of the manuscript, and the relevant ethics documents, all of which have met the basic publishing requirements</p>
