The topic is within the scope of the WJGE. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: The authors presented a systematic review of major literature evaluating the role of ETGBD for patients with acute cholecystitis. It is of interest.</p>	[Y]

However, the language needs to be revised. The questions raised by the reviewers should be answered; and (3) Format: There are 5 figures. (4) References: A total of 46 references are cited, including 8 references published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves.
