the Peer-Review Report: The authors investigated the effects of senescence on the trans-differentiation capacity and mitochondrial metabolism of the human HepaRG cells. It is well-constructed and it provides valuable information to the readers. However, the questions raised by the reviewer should be answered; and (3) Format: There is 1 table and 5 figures. (4) References: A total of 51 references are cited, including 7 references published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves. If the authors found the peer reviewer(s) request the authors to cite improper references published by themselves, please send the peer reviewer's ID number to the editorialoffice@wjgnet.com. The topic has not previously been published in the WJSC. 5 Issues raised: (1) The title is too long, and it should be no more than 18 words; (2) The authors did not provide the approved grant application form(s).
