The topic is within the scope of the World Journal of Hepatology. (1) Classification: Grade C and Grade C; (2) Summary of the Peer-Review Report: 1) Review 1 did not see the final result data. 2) Review 2 listed 5 questions directly on the PDF file of the manuscript, and asked the author to reply. 3) The submission date is before the end date of the clinical trial. The questions raised by the reviewers should be answered; (3) Format: There are 0 tables and 1 figures; (4) References: A total of 17 references are cited, including 7 references published in the last 3 years; (5) Self-cited references: There are 2 self-cited references. The self-referencing rate should be less than 10%. Please keep the reasonable self-citations (i.e. those which are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; 2 Language evaluation: Classification: Grade C and Grade A. A language editing certificate issued by Antonia Carbone was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and the Institutional Review Board Approval Form.
