It should be clarified why the found publications were not included in the review. The questions raised by the reviewers should be answered; (3) Format: There are 3 tables</p>	[Y]

and 6 figures; (4) References: A total of 47 references are cited, including 11 references published in the last 3 years; (5) Self-cited references: There is 1 self-cited references. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate and the PRISMA 2009 Checklist. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJO. 5 Issues raised: (1) The language classification is Grade B. Please provide the original figure documents.
