The questions raised by the reviewers should be answered; (3) Format: There is 1 table and 1 figure; (4) References: A total of 72 references are cited, including 10 references published in the last 3 years; (5) Self-cited references: There are 2 self-cited references. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by Proof-Reading-Service was provided. 3 Academic norms and rules: No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJGE. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) For PMID and DOI numbers of references from English-language journals, please ensure the PMID and DOI numbers in the square brackets. PMID numbers are not required. 6 Recommendation: Conditional acceptance.
