The topic is within the scope of the WJCC. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: The</p>	[Y]

authors present an interesting case of acute arterial thrombosis which occurred shortly in the post-operative period. However, the authors have not discussed rhabdomyolysis in the manuscript. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 3 figures. (4) References: A total of 33 references are cited, including 1 reference published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves. If the authors found the peer reviewer(s) request the authors to cite improper references published by themselves, please send the peer reviewer's ID number to the editorialoffice@wjgnet.com. The Editorial Office will close and remove the peer reviewer from the F6Publishing system immediately. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by Editage was provided. 3 Academic norms and rules: The authors provided the CARE Checklist-2016 and Written informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The title is too long, and it should be no more than 18 words; and (2) The authors did not provide original pictures. Please provide the original figure
