	<p>been fully discussed. Several experimental methods were not described in detail in this paper, and the contents of mesenchymal stem cells unrelated to this paper appeared in many parts. Therefore, I suggest reject this manuscript.</p> <p>Company Editor-in-Chief: I have reviewed the Peer-Review Report, the full text of the manuscript, and the relevant ethics documents, all of which have met the basic publishing requirements of the World Journal of Stem Cells, and the manuscript is conditionally accepted.
